

2015 Annual Meeting

MEMBERSHIP REPORT

The year since the last Annual Meeting has been a time of constant change in MLPA's membership, perhaps reflecting the change that has been going on in the MLP world. We had an extraordinarily large number of new members, but also lost an extraordinarily large number of members to mergers and other circumstances. As a result, while membership and dues income continued to grow, the net growth was lower than it has been in other years.

At the time of last year's Annual Meeting, we had 155 members. As of now, the number of MLPA members stands at 165, a net increase of ten members since July 2014. There are 96 MLP members representing 105 MLPs, 41 service company members, and 28 associate members.

Between renewing members and new members joining this year, we have accrued \$1,603,720 in dues in 2015, of which over 98% percent has been paid. This represents a modest 2.6% increase over the \$1.56 million in dues we received in 2014.

Since the last Annual Meeting, we have welcomed 29 new members to the Association. As is often the case, many of the new MLP members joined in the months prior to the Investor Conference in order to participate:

This increase was offset, however, by 19 departures, for a net increase of only ten members. Some MLP departures resulted from mergers and acquisitions (Access Midstream Partners, Kinder Morgan Energy Partners, Marlin Midstream Partners (to be replaced by Azure) Oiltanking Partners, PetroLogistics, QEP Midstream Partners, QR Energy Partners, and Regency Energy Partners). The rest (Alon USA Partners, Energy Transfer Partners, Niska Gas Storage Partners, Rhino Resource Partners, Sunoco Logistics Partners, and Sunoco, LP) left the Association for various other reasons. Also leaving were service companies Bingham McCutchen; FT; Grant Thornton; Simpson, Thatcher and Bartlett; and White and Case.

The growth in the number of MLPs has moderated over the past year, thanks to consolidation and less favorable markets. If these trends continue, we may find that continued growth in membership will be harder to achieve than it has over the last several years.
