

MLPA IR/PR COMMITTEE REPORT September 27, 2018

The IR/PR Committee provides the following report to the Membership.

MLP & Energy Infrastructure Conference (MEIC)

The 2018 Investor Conference was rebranded to the "MLP & Energy Infrastructure Conference (MEIC) – *Connecting the Value Chain*" and expanded to include energy infrastructure c-corps and yield cos. MEIC was held at the Hyatt Regency in Orlando, Florida on May 22-24, 2018. As compared to the 2017 conference, MEIC 2018 experienced an increase in registrations, attendance, sponsorships, 1x1 meetings, revenue and profit.

Although the number of MLPs participating was below last year – 57 in 2018 v. 62 in 2017, the number of participating companies in 2018 represented a higher percentage of the MLP universe given simplifications and other transactions. Additionally, the number of registered presenting companies stood at 64 two weeks prior to MEIC 2018. FERC's March 15 announcement regarding its Revised Policy Statement on the Income Tax Allowance played a role in companies deciding to forgo participation given simplification, structural and other strategic plans. This year, 24 companies conducted formal presentations v. 26 in 2017, while 8 companies participated in fireside chats v. 10 in 2017.

There were 839 registrants compared to 811 in 2017, representing more than 330 individual companies, including 113 investor firms and 42 banks. Sponsorship revenues were up 3% YoY. YoY revenue increased 9.2%, expenses increased 8.8% and net profit improved 9.6%. The increase in expenses was primarily due to moving to a cube farm configuration for 1x1 investor meetings.

2019 MEIC

2019 MEIC will be held at the Aria Resort & Casino, Las Vegas, Nevada on May 14-16, 2019. Like this year, invited companies will include MLPs, yield cos, energy infrastructure C-corps and REITs. More panels, additional 1x1 time slots to accommodate smaller meeting sizes as well as keynote speakers are planned. Additional information on 2019 MEIC will be released shortly.
